## **Park County Weed and Pest Priority Response Crew Job Description**

### **General Summary**

The main duty to be performed will be the early detection and rapid response to high priority noxious weeds within Park County. Most of the work will be treatment, survey, and GPS cataloging of these species across varied terrains and ecosystems. The crew will utilize maps, GPS equipment, backpack sprayers, other tools, and 4x4 pickup to complete duties. Other duties may include pest detection, coordinating field operations, support of other crews, and working with landowners or other agency personnel to complete the District's work plans.

The normal work week will be 40 hours, Monday-Thursday. This job is a non-exempt at-will position and any overtime earned will be compensated at a rate of 1 ½ times regular pay.

Training will be provided to individuals hired so they may meet and exceed all District goals and some minimum requirements.

### **Minimum requirements**

- Priority Response crew members must be 18 years old and have a valid driver's license and a driving record that does not affect insurability of the applicant.
- Have the ability to carry a specialized backpack sprayer and lift loads weighing up to 45 pounds.
- Have the ability to work under adverse weather conditions occasionally hiking several miles per day to inventory and/or treat off-road areas or remote areas.
- Be a self-motivated team-player who is able to work in a supervised or unsupervised manner.
- Be able to identify noxious weeds and other plants at various growth stages (training provided).
- Obtain a Wyoming Commercial Applicator's License (training provided).
- Apply pesticides as needed in accordance with District policies and state and federal laws and regulations.
- Prepare records and reports regarding chemical usage/inventories.
- Be responsible for ensuring all work and activities are performed safely and in accordance to District policies and procedures.
- Perform other duties as directed.

### **Knowledge, Skills, and Abilities**

Good communication skills, attention to detail, punctuality, and professional attitude are of the utmost importance for these positions. Ability to work as a team to complete tasks is highly desired. A working knowledge of county geography, noxious weeds and other plants, sprayers and sprayer maintenance, 4X4 trucks, GPS, basic computing, math, and map reading are desired for these positions.
